DONOR RECOGNITION PLAN

In September 2019, Transport Canada granted CIAC funding to develop enhanced training tools and to expand outreach events under the TRANSCAER program. CIAC has delivered on the first components of the project, and the remaining portion of this funding has been allocated to support the development of TRANSCAER's new Safety Train.

Under the funding agreement with Transport Canada, approximately half of the costs associated with the fit-up of the new Safety Train are eligible for reimbursement. CIAC has committed funds to support the project and is seeking additional donations from members and industry partners to cover the remaining project costs, which will ensure the successful completion of a quality training tool.

To date CIAC has raised \$113,500 and is looking to secure another \$60,000 to cover the anticipated costs of the project.

Donor Benefits – Recognition and Duration


